Operations – Fire Chief Andy Kovacs/Battalion Chief Janaka Branden

Summary of Significant Events:

- On March 12^{th,} Chief Coyle and I attended the AIMS Community College Fire/EMS career recruitment event. We discussed career opportunities and presented information about MFD to students.
- On March 13th, I attended a Shield 616 event to receive ballistic vests for four MFD firefighters and various local law enforcement agencies purchased through community member donations.

Operations:

A Shift - Battalion Chief Pearson

- 3/18, BC Pearson attended the County MCI Committee meeting.
- 3/27, Station 5 hosted a 3rd rider.
- 3/28, BC Pearson attended a Colorado Regional Medical Operations Center (RMOC) planning meeting.
- Throughout the month, personnel were trained on the new ladder truck.

B Shift - Battalion Chief Coyle

- On 3/1, crews responded to an ice rescue at Monument Lake. Crews rescued one party that fell into the lake. Crews also rescued three additional parties stranded on the ice. Crews brought them to shore using the inflatable boat.
- On 3/7, crews performed tremendously well during a sudden ice storm that affected the Monument region. Hundreds of cars were involved in accidents or had slid off the road, causing impassable roadways and unsafe driving conditions for emergency vehicles.
- On 3/13, crews participated in Red Energy PR videos. Several crew members were interviewed.
- On 3/13, crews responded to the Meridian Road Fire in Ellicott that burned 2500 acres.
- On 3/31, Station 4 provided a station tour for a local Boy Scout troop.

C Shift - Battalion Chief Mola

- From 3/17 to 3/18, we had 48 calls for service. Twenty-six of those calls were from a fast-moving ice storm that moved in.
- On 3/29, MFD closed I-25 twice due to traffic accidents involving inclement weather, numerous vehicles, and tractor-trailers involved.
- On 3/29, MFD responded to a hazardous material call at the Monument Post Office that was mitigated with MFD units.






Incidents by Call Type - March




- Fire calls include structure fires, outside fires, and others.
- Hazardous conditions include spills/leaks, chemical release, electric wiring/equipment problems.
- Public assistance includes a person in distress or assistance required (e.g., lift assist).
- Good intent includes canceled enroute, no emergency fund, and controlled burn.
- Fire alarms include false alarms, system malfunctions, and unintentional system activation.



Incidents – Top 3 Response Categories – March




Ambulance Transports - March






Ambulance Automatic/Mutual Aid – March




Calls are dispatched and enroute, and do not consider cancellations. ${\sf MFD} \ to \ {\sf AMR-0} \ calls \ accepted.$
